[Position Description: PASBO Candidate for ASBO International Board of Directors](#)

PASBO is seeking qualified active members to apply to PASBO's ASBO Nominations and Election Committee for endorsement as a director for a three year term beginning January 1, 2021 followed by three years as an officer beginning January 1, 2024 (vice president, president and immediate past president).

The successful candidate should have proven leadership skills and extensive engagement with PASBO in such positions as a regional chapter member and officer, committee member, board of directors, officer, *PASBO Report* contributor and professional registration.

The successful candidate must be able to make a commitment to extensive national travel as a candidate beginning at the ASBO Executive Leadership Forum, February 8-10, 2018 in Austin, Texas. The campaign effort will continue until the ASBO election beginning in August 2020. The estimated travel commitment to ASBO International events and ASBO affiliate meetings is 3-5 events per year depending upon the other director candidates in the 2021 election. At this time, there are no other announced candidates.

Through a fund raising effort, PASBO will commit resources to offset most travel expenses of the candidate. Costs expected to be absorbed by the candidate include spouse travel and attendance at the ASBO International Annual Meeting (2018-2020). PASBO will also fund campaign materials and election mailers. The successful candidate must commit to taking an active role in leading the fund raising effort with the support of previous ASBO International Past Presidents, the PASBO Executive Director and regional chapters.

The schedule for the selection process is as follows:

Application Deadline—November 30, 2017

Interviews—December 12 or 14, 2017 at the PASBO Office in Harrisburg

Final Action by PASBO Board of Directors—January 26, 2018

Notification to Candidates—January 26, 2018

Attached are election documents from ASBO International. You are encouraged to read them thoroughly. Please make sure you comply with the following:

An eligible director candidate is one who:

1. Has been and qualifies as a Professional or Life member for at least five (5) of the past seven (7) years prior to the filing deadline as established by the Election Committee.
2. Has attended at least three (3) of the last six (6) annual meetings.
3. Has complied with the election rules and regulations as prescribed by the board of directors.

To be considered by the Nominations and Election Committee you should send a letter of application indicating your interest and qualifications for the position and a current resume by the deadline to the chair of the committee. In addition you must provide a letter of support from your superintendent/executive director.
